The McKean County Community Foundation (MCCF) is a vehicle for individuals, families, not-for-profit organizations and businesses to establish permanent named funds that will provide grants in perpetuity to the widest range of local charitable organizations and programs.

- MCCF was founded in 2017 by a group of community leaders from McKean County as an affiliate to the Community Foundation of the Northern Alleghenies
- It is one of 750 Community Foundations in the United States, 37 in Pennsylvania
- The Governing Board is made up of 11 citizen volunteers from across McKean County

Distributions to be decided by MCCF.

Donor decides now who beneficiary will be.

Not-for profit organization uses MCCF to start and build its own endowment. Distribution only to that organization.

Donor decides now on types of beneficiary.

Donor advises MCCF annually as to preference of beneficiary.

Fund can be started with a small gift to be fully funded in several years.

As of August 2018 assets total approximately \$194,000 in 14 named funds.

In 2018 seventeen scholarships were awarded totaling over \$11,000.
